**Oakley City Council Meeting Minutes** Wednesday July 22, 2020 Oakley City Hall

6:00 p.m.

- 1. Call to order and roll call
  - a. City Council: Councilmembers Wilmoth, Smart (via Zoom), Neff, Frazier, Bowen
  - b. City Staff: Amy Rydalch, City Planner, Abigail Morrison, City Recorder, Kendell Staples, Public Works Director
  - Other: Sam Aplanalp, Planning Commissioners Zane Woolstenhulme, Doug Evans
- 2. Invocation and Pledge of Allegiance
- Discussion regarding possible city land acquisition City Planner

Amy Rydalch, City Planner, led a discussion regarding a piece of property that has recently been put on the market. The property abuts city land and is zoned commercial. The owners are asking for \$800,000. Ms. Rydalch stated she was bringing it to the attention of City Council as a potential option and to see if they would like her to approach the current owners. Councilmember Frazier stated the price was high, but it would not hurt to make inquiries. Councilmember Wilmoth also felt the price was high, but echoed Councilmember Frazier's thoughts. Ms. Rydalch will look at further possibilities.

4. Arena Event Fees – Kendell Staples, Public Works Director

Kendell Staples, Public Works Director, said there has been confusion with city staff and the public regarding the fee schedule for arena use. He presented a new proposed rate schedule (attachment A). Councilmember Wilmoth asked about fees for entire park usage, parking lot usage, and the dump station. He stated that it seems unlikely that everyone is paying for the use of the dump station and suggested making it free of charge if the city is not even getting the fees it should be. Ms. Morrison stated that, while the city likely does not capture fees from every user, the city does still receive income from it and recommended keeping a fee. Councilmember Wilmoth asked how the fees are gathered and Mr. Staples said that the are given at the office most often, but soon there will be a lock box installed that will make it easier. Councilmember Wilmoth suggested raising the fee from \$5.00 to \$10.00 and installing the lockbox as soon as possible to capture more fees. Mr. Staples said there have been a few requests for the parking lot, but not an overwhelming number. Councilmember Neff asked how many campsites are available. Mr. Staples said we have 18 campsites in the campground and 10 RV sites at the Recreation Complex grounds. There was discussion about offering a slightly discounted rate for family reunions at the campground. It was reiterated that priority should be offered to family reunion groups and for a discount. Councilmember Neff asked for clarification on renting the city hall. Ms. Rydalch, City Planner, feels uncomfortable renting the city hall because staff have offices and she feels they are not completely secure. Councilmember Frazier stated that it would be possible to install better locks and put a door on the stairs to prevent the public from going upstairs at all. Councilmember Neff voiced support for this solution. There was general discussion about installing new locks if needed. Ms. Morrison pointed out that the City Hall has not been rented in five months anyway due to COVID-19 measures, so this decision may not be urgent. Councilmember Bowen stated that multiple people have

39 complained to him about the outdoor arena not being free anymore. He feels that, unless the arena is actively 40 rented, an individual should not need any kind of pass (day, monthly, or annual) to ride in the outdoor arena. City 41 Council stated that the fees were instated to try to capture some of the money that is spent on arena 42 maintenance. Councilmember Bowen stated that he does not see a difference between playing on a soccer field 43 without a reservation and riding at the arena without a reservation and fee. Councilmember Neff asked what the 44 public felt. Zane Woolstenhulme, Planning Commission Chairperson, stated that in the past Oakley residents did 45 not need to pay for the outdoor arena if there was nobody there and he did not see a problem with that policy. 46 Councilmember Bowen said it was fair to allow people to use it for free if it was not rented.

Councilmember Neff made a motion to eliminate the pass requirement for the outdoor arena and open use to the general public unless it is otherwise rented. Councilmember Smart seconded. Motion passed.

Councilmember Frazier made a motion to approve fee changes as discussed in this meeting. Councilmember Neff seconded. Motion passed.

### 5. Water System update and discussion – Dallas Hansen, City Water Operator

Dallas Hansen, Oakley Water Operator, presented information about the Oakley City Water System especially with regards to securing a secondary water source. He said that one of the disadvantages to running a wet well is pulling water out of the Rich's Ditch. Councilmember Wilmoth said that he and Dallas had earlier discussed that getting the Recreation Complex off culinary water would free up almost half of the current water being used. He asked Mr. Hansen how soon the city could do that. Mr. Hansen stated that he does not see that being feasible during this season. Councilmember Bowen asked about chlorination at the Cottonwood Spring. Mr. Hansen said they are actively chlorinating at the spring now. Councilmember Frazier asked if all the springs are running. Mr. Hansen said that the city is running two sources (the only sources). Councilmember Neff asked about the impact of Oakley Water Bottling Company. Mr. Hansen said they have not filled bottles since April 2020. Councilmember Neff asked about Maple Ridge water usage. Mr. Hansen stated that the meters were incorrect at Maple Ridge and that a lot of water usage goes to water features, ponds, and pools. Councilmember Wilmoth stated that he would like the city to develop a permitting system for extra water features like those. Councilmember Frazier stated support for that idea. Doug Evans, Planning Commissioner, stated that he has drafted water rules and regulations which includes a section on ponds and back flow prevention. He stated that pond services can legally be terminated at anytime if there is a water shortage in the city. He stated the city has the right to make rules and regulations regarding water at any time. The most important service is to provide clean drinking water to citizens. He urged the city to act with caution if they decode to dig a well. He said that years ago Oakley spent \$500,000 on a well next to Oakley Water and it only produced five gallons per hour. He also said that once Oakley City is on gas chlorination nobody in Oakley will notice the taste. Mr. Evans said that part of a Capital Facility Plan would include looking at water rights.

#### 6. Recommendations for Long Term Planning –Oakley City Planning Commission

Zane Woolstenhulme, Planning Commission Chairperson, thanked the city council for the opportunity to serve Oakley City. He stated that there are many challenges currently facing Oakley City, and there will be more challenges in the future with future demands on development. He stated that the City has taken a reactive approach and it is time to take a proactive approach. Planning Commission has discussed water usage and infrastructure. One of the things Planning Commission is recommending tonight is a moratorium on any subdivisions for the next six months. Planning Commission would like to take that time to put in a new General Plan. He asked City Council to look at the proposals from Planning Commissioner Doug Evans. Much of what was drafted deals with water use. He stated the need for a Capital Facilities Plan. The City needs a basis upon which

fees are proposed and a plan would do that. He recommended hiring a consulting to work with City Council and the Planning Commission. Councilmember Bowen supported the request to pursue a plan. Mr. Woolstenhulme stated that interest rates are very low right now and it would be a good time to look at bonding for future water improvements that would take a 50-year plan into account. He stated that the sewer facility is running at nearly full capacity and the city needs to look at future improvements there. Councilmember Neff said he would like to look at a 30-50-year plan to plan for future water and sewer. Councilmember Frazier stated support and said that the city could take on more debt at this time. He is in support of financing and formulating a plan. Councilmember Smart stated that they were told the sewer plant was at two thirds capacity two years ago. Mr. Evans stated that the sewer lines were originally put in in the 1960's and there is a lot of infiltration and damage to that system which causes a lot of ground water and other material to be processed at the plant that should not be. Councilmember Smart thanked him and stated full support for the efforts of Planning Commission. Mr. Evans stated that looking at these problems will be very beneficial for Oakley City in the long run. Right now, the city is in a dangerous place because if the Humbug Well went down, Oakley residents could be left without water. The city needs a backup plan. Councilmember Smart asked about the moratorium on subdivisions and how it would affect building permits. Mr. Hansen said that one of the biggest problems was with people connecting onto water. The city can adopt a moratorium that just prevents that kind of building permit. Councilmember Neff asked Mr. Woolstenhulme to look at costs. Mr. Woolstenhulme stated that all contracts would need to be approved by City Council and that he will come to City Council with plans at future meetings. Councilmember Frazier asked for more clarification on what would be banned in the moratorium and Mr. Evans said one test is to stipulate that any building permit that would require an impact fee will not be issued in the next six months.

7. Possible Adoption of Temporary Land Use Regulation

Councilmember Frazier made a motion to adopt the moratorium on development and building permits that require an impact fee starting August 1, 2020. Councilmember Bowen seconded. Councilmember Frazier amended the proposal to be in effect immediately. Councilmember Bowen seconded. Councilmember Neff – Aye, Councilmember Frazier – Aye, Councilmember Smart – Aye. Motion passed.
