OAKLEY CITY RESOLUTION # 2021-06 A RESOLUTION SETTING NEW CULINARY WATER RATES

WHEREAS: Oakley City owns and operates a culinary water system, and

WHEREAS: Costs associated with managing and operating the culinary water system continues to increase, and

WHEREAS: The Oakley City Mayor and City Council sees the need to make improvements to the culinary water system, and

WHEREAS: Financial assistance from various funding agencies will be necessary in order to make the needed system improvements, and

WHEREAS: The funding agencies require that the city water rates meet certain criteria, which Oakley City's water rates do not currently meet, and

WHEREAS: The Mayor and City Council have had a Water Rate and Budget Analysis completed which shows the need for the City to acquire additional revenue for the Water Enterprise Fund, in order to qualify for financial assistance for the needed projects, and also to be able to better serve the citizens of Oakley City, and

WHEREAS: Oakley City has adopted as Ordinance governing its operation which provides, among other things, the right to change or fix water rates by resolution,

NOW THEREFORE IT IS HEREBY RESOLVED BY THE MAYOR AND TOWN COUNCIL OF OAKLEY CITY, SUMMIT COUNTY, UTAH, AS FOLLOWS:

SECTION 1: WATER RATES. All water rates or user fees historically charged, for water services, are hereby ratified and confirmed.

As of July 1, 2021, the monthly water user rates shall be as follows:

RESIDENTIAL USERS: Base Rate: \$25.00 for up to 7,000 gallons

Usage/Overage: \$1.50 per 1000 gallons from 7,001 – 15,000 gallons 2.00 per 1000 gallons from 15,001 – 40,000 gallons 3.00 per 1000 gallons from 40,001 – 160,000 gallons 8.00 per 1000 gallons from 160,001 gallons and up

NEWPORT ACADEMY: (24 ERU's) Base Rate: \$600.00 for up to 168,000 gallons

1.50 per 1000 gallons from 168,001 – 360,000 gallons 2.00 per 1000 gallons from 360,001 – 960,000 gallons 3.00 per 1000 gallons from 960,001 – 3,840,000 gallons 8.00 per 1000 gallons from 3,840,001 gallons and up **ELK MEADOWS:** (15 ERU's) Base Rate: \$375.00 for up to 105,000 gallons 1.50 per 1000 gallons from 105,001 – 225,000 gallons 2.00 per 1000 gallons from 225,001 – 600,000 gallons

3.00 per 1000 gallons from 600,001 – 3,400,000 gallons

8.00 per 1000 gallons from 2,400,001 gallons and up

MAPLE RIDGE: Base Rate: \$30.00 for 0 gallons

2.00 per 1000 gallons from 0-10,000 gallons 2.50 per 1000 gallons from 10,001-20,000 gallons 3.50 per 1000 gallons from 20,001-40,000 gallons 4.50 per 1000 gallons from 40,001-100,000 gallons 9.50 per 1000 gallons from 100,001 gallons and up
