STATE REQUIRED WATER INSPECTIONS LEAD/COPPER RULE AND CROSS CONNECTION

LEAD/COPPER RULE: Updated Federal Law requires water systems to identify the type of material used in culinary water connections. This is an effort to locate areas for needed sampling to test for lead and copper levels in the home or facility. Oakley City has identified approximately 150 homes where the materials used for the water connection coming into the home is unknown. The City will be reaching out to these homeowners for assistance.

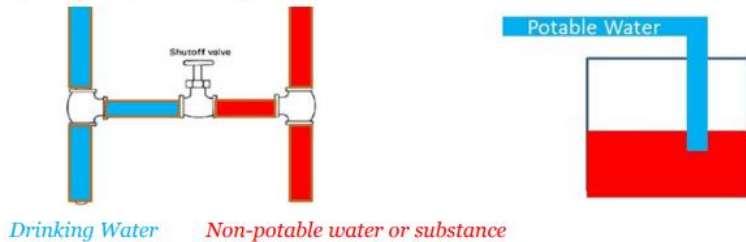
CROSS CONNECTION: Beginning this year, the State is requiring inspections for cross connection and backflow prevention. The City of Oakley will be performing these inspections by area. Water Cross Connection

What is a Cross-Connection?

A cross-connection is a physical connection (piping configuration) between the public drinking water system and anything else, including another

water supply that can allow undesirable pollutants or contaminants to backflow into the public drinking water system.



What is Backflow?

Backflow is the reversal of flow from a residential or commercial water system back into the public drinking water system. A backflow incident could occur if the water systems pressure decreases, or the

customer's water pressure is higher than the water systems pressure. A backflow incident could carry pollutants or contaminants into our public drinking water supplies making them unsafe to use.



The Plumbing Code and the Utah Public Drinking Water Rules require that all cross connections be eliminated or protected against backflow by installing an

approved backflow device or assembly that will insure that no impurities or contaminants are introduced to the public drinking water supply.

How does this apply to me?

State law requires that devices be placed on **EVERY HOME** to prevent cross-connection. Hose bib adapters need to be placed on all outdoor hose spigots. City staff will have these available for purchase at the time of your inspection.

If your landscaping sprinkling system is connected to culinary water, an approved backflow prevention device or assembly is required.
